CUBA	Cuban Assets Control Regulations (CACR), 31 C.F.R. §515.575 Humanitarian projects	<ul> <li>Certain travel-related transactions (see 31 CFR §515.560(c)) by persons subject to US jurisdiction related to humanitarian projects in or related to Cuba designed to directly benefit the Cuban people.</li> <li>31 C.F.R. §515.575(b) addresses medical and health-related project transactions, including travel-related transactions, for humanitarian projects in Cuba, such as disaster preparedness, relief, and response, and projects to meet basic human needs.</li> </ul>
	CACR, 31 C.F.R. §515.548 Overflight payments, emergency landings, and air ambulance service	• Transactions by persons subject to US jurisdiction necessary for air ambulance and related medical services, including medical evacuation, for individual travelers in Cuba, authorized.
IRAN	Iranian Transactions and Sanctions Regulations (ITSR), 31 C.F.R. §560.530 Commercial sales, exportation, and reexportation of agricultural commodities, medicine, medical devices, and certain related software and services.	<ul> <li>Unless excluded, 31 C.F.R. §560.530(3)(i) authorizes the exportation or reexportation of agricultural and medical goods by a US person or US-owned or -controlled foreign entity to the Government of Iran, any individual or entity in Iran, or to persons in third countries purchasing specifically for resale to the foregoing.</li> <li>Note: Shipments must take place within 12 months of the signing of a contract for the export or reexport.</li> <li>Training related to safe and effective use of medicine and medical devices covered by the GL are authorized at 31 C.F.R. §560.530(3)(v).</li> <li>See 31 CFR §560.532 for payment terms that are authorized in relation to exports or reexports under 31 CFR §560.530.</li> <li>US persons are authorized at 31 C.F.R. §560.533 to engage in brokering of sales of agricultural commodities, medicine, and medical devices <i>by US persons</i> covered by GL.</li> <li>Note: Per the EAR, at 15 CFR §746.7, if OFAC authorizes an export or reexport subject to the ITSR, such authorization also applies to items subject to the EAR.</li> </ul>

IRAN	GL-E Authorizing Certain Services in Support of Nongovernmental Organizations' Activities in Iran	<ul> <li>NGOs authorized to undertake transactions, including services, in support of not-for-profit activities with Iran related to (i) provision of donated health-related services, (ii) provision of relief services related to natural disasters, (iii) distribution of donated articles (food, clothing, medicine) intended to relieve human suffering, and (iv) donated training for the foregoing.</li> <li>Note: See §560.210(b) for an exemption under the ITSR for US persons donating articles, such as food, clothing, and medicine, intended to be used to relieve human suffering.</li> <li>Note: Transactions, services, or training cannot exceed US\$500,000 in the aggregate over a 12-month period. Quarterly reporting requirement to OFAC about disbursements as required.</li> </ul>

NORTH KOREA	EAR, 15 C.F.R. §746.4(a) Embargoes and Other Special Controls – North Korea	• BIS license required for items subject to the EAR <i>except food and medicine designated as EAR 99</i> .
	North Korea Sanctions Regulations (NKSR), 31 C.F.R. §510.512 Certain services in support of nongovernmental organizations' activities	<ul> <li>US NGOs authorized to export or reexport <i>services</i> in support of notfor-profit activities, including distribution of medicine and health-related services and non-commercial projects directly benefiting the North Korean people, including infectious disease prevention.</li> <li>31 C.F.R. §510.512(b) authorizes export or reexport of medicine from a third country, provided it is not subject to the EAR.</li> <li>US banks, broker-dealers, and money transmitters are authorized under 31 C.F.R. §510.512(c) to process funds transfers on behalf of <i>both</i> US and non-US NGOs in support of activities described in 31 C.F.R. §510.512 (a) to (c).</li> </ul>

	Syrian Sanctions Regulations (SSR), 31 C.F.R. §542.510 Exports or reexports to Syria of items licensed or otherwise authorized by the Department of Commerce authorized; exports or reexports of certain services authorized	• Exports and reexports by US persons of items authorized by BIS as well as services ( <i>e.g.</i> , funds transfers) that are ordinarily incident to the export or reexport of such items to Syria authorized.
	SSR, 31 C.F.R. §542.525 Exportation or reexportation of services to Syria related to the exportation or reexportation of certain non-US-origin goods authorized	• US persons authorized to provide services (e.g., funds transfers) ordinarily incident to the export or reexport of non-US origin medicine and medical devices that would be designated as EAR 99 if subject to the EAR.

	GL-26 Emergency and Certain Other Medical Services Authorized <sup>4</sup>	• US persons authorized to provide and receive nonscheduled emergency medical services otherwise prohibited by the Venezuela Sanctions Regulations (VSR) or Venezuela-related EOs and "other medical services" involving the Government of Venezuela prohibited by EO 13884.
	GL-29 Certain Transactions Involving the Government of Venezuela in Support of Certain Nongovernmental Organizations' Activities Authorized <sup>5</sup>	• US persons authorized to engage in transactions involving the Government of Venezuela that are ordinarily incident and necessary to certain activities of NGOs including provision of health services, distribution of food and medicine, and non-commercial development projects directly benefiting the Venezuelan people, including preventing infectious disease.
